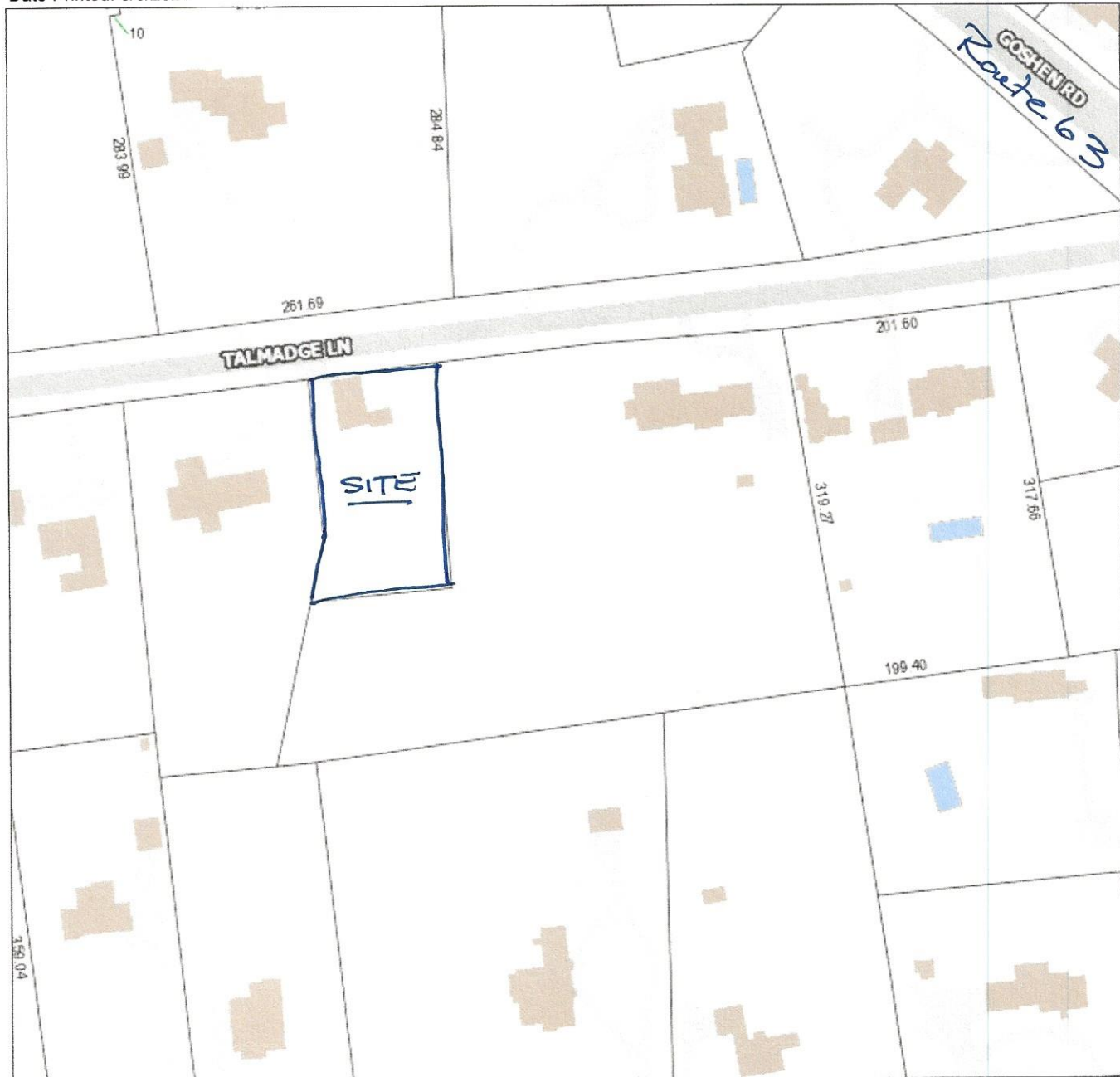

Geographic Information System (GIS)



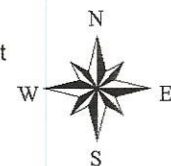
