APPLICATION REVIEW

Green 19 Little Pitch Rd. 5/17/21

Two lot re-subdivision 9.03 acres (4.88 acres, 4.15 acres) – PH set for June 7, 2021.

Scott Lukowski, P.E. of Dymar was present for the application. New plans were submitted removing the un needed well location and showing the location of the water line to the newly created lot. Issues submitted by the Fire Marshal regarding fire protection were addressed. They are leaning toward providing a fire hydrant. The Chair requested a new plan showing the location of the proposed water line and hydrant. They are getting comments from Aquarion addressing the water line and the hydrant.

A discussion ensued regarding the steep slopes that are included in the 200' building square. Dr. Tobin requested an affidavit stating that the land is going to be transferred to a family member to satisfy Section 7, 9(m) (ix) of the Subdivision regulations which address the open space requirement of a fee in lieu of open space. The chairman expressed concern regarding the steep slope on the west side of the lot. Dr. Tobin suggested the applicant could apply for a waiver as presented in the subdivision regulations Section 3 (2). Additional information requested from the applicant for the public hearing on June 7 were the deed for the property and TAHD approval.
